Nichols was killed by being shot as a result of the perpetration of or the immediate flight from the perpetration of the class A felony of robbery in the first degree under Section 570.023, RSMo. committed by the defendant, either acting alone or in concert with others, on or about November 19, 2018, in the County of Cole, State of Missouri.




or in concert with others, forcibly stole a handgun owned by M.S., and in the course thereof defendant or co-defendant's were armed with a deadly weapon.
