INDICTMENT

COUNT: I

Charge Code: 565.021-003Y19840999.2

The Grand Jurors of the County of Cole, State of Missouri, charge that the defendant, in violation of Section 565.021, RSMo, committed the class A felony of murder in the second degree, punishable upon conviction under Section 558.011, RSMo, in that on or about on or about November 19, 2018, in the County of Cole, State of Missouri, Nilez R. Nichols was killed by being shot as a result of the immediate flight from the perpetration of the class B felony of burglary in the first degree under Section 569.160, RSMo. committed by the defendant on or about November 19, 2018, in the County of Cole, State of Missouri.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

COUNT: II

Charge Code: 569.160-001Y20172299.0

The Grand Jurors of the County of Cole, State of Missouri, charge that the defendant, in violation of in violation of Section 569.160 RSMo. committed the crime of burglary in the first degree punishable under Section 558.020 RSMo. in that on or about November 19, 2018 in the

County of Cole, State of Missouri, the defendant, acting with others, knowingly entered unlawfully and knowingly remained unlawfully in an inhabitable structure for the purpose of committing an offense of assault and robbery, and when in effecting entry or while in the building or inhabitable structure or in immediate flight therefrom, the defendant or another participant in the offense was armed with a deadly weapon; and defendant threatened immediate physical injury to any person who is not a participant in the crime and there was present in the structure another person who was not a participant in the crime.
