I, **TPR R. MALONE**, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.
 1. I have probable cause to believe that **GORDON B CHRISTIE**, currently residing at **80 COTTON RD, LAKE OZARK, MISSOURI, 65049**, born: [REDACTED], committed the offense(s) listed below on **12-31-2019**, at/on **US-54 WB NEAR MT CARMEL ROAD** in Miller County Missouri.

2. State the facts that support a finding of probable cause to believe crime(s) was/were committed and that the accused committed the crime(s)

ON 12/31/2019 AT 2159 HOURS, I STOPPED CHRISTIE FOR SPEED (80-70) ON WESTBOUND US 54 NEAR TOLWOOD ROAD, IN MILLER COUNTY, MISSOURI. CHRISTIE WAS THE SOLE OCCUPANT OF THE VEHICLE. UPON CONTACT WITH CHRISTIE, I SMELLED THE STRONG ODOR OF AN INTOXICATING BEVERAGE COMING FROM WITHIN HIS VEHICLE. I OBSERVED CHRISTIE SMOKING A CIGARETTE, TAKING LONG, DRAWN OUT PUFFS. I OBSERVED HIS EYES TO BE BLOODSHOT, GLASSY, AND WATERY. I HEARD CHRISTIE'S SPEECH TO BE HEAVILY SLURRED. WHEN ASKED TO RETRIEVE HIS VEHICLE'S INFORMATION, CHRISTIE HAD DIFFICULTIES LOCATING THE PAPERWORK. WHILE SPEAKING WITH CHRISTIE, I OBSERVED HIS BEHAVIOR TO BE AGGRESSIVE, ARGUMENTATIVE, CONFRONTATIONAL AND ANTI GOVERNMENT.

I ASKED CHRISTIE WHERE HE WAS TRAVELING FROM. CHRISTIE STATED HE WAS COMING FROM TOOTER'S BAR. I ASKED CHRISTIE IF HE HAD CONSUMED ANY ALCOHOL. CHRISTIE STATED HE HAD CONSUMED SEVERAL BEERS AND MIXED DRINKS THROUGHOUT THE NIGHT. I ASKED CHRISTIE WHERE HE WAS TRAVELING TO. CHRISTIE THEN STATED, "I'M HEADED TO THE STRIP TO SHOOT UP THE PLACE. " I ASKED CHRISTIE WHY HE FELT HE NEEDED TO COMMIT GUN VIOLENCE. CHRISTIE STATED, "YOU DON'T CARE ABOUT MY MENTAL HEALTH. " I ASKED CHRISTIE IF HE HAD A WEAPON. CHRISTIE STATED HE HAD A PISTOL ON HIS RIGHT HIP. I INSTRUCTED CHRISTIE TO EXIT THE VEHICLE AND RETRIEVED THE PISTOL (A GLOCK MODEL 23). I LOCATED THE PISTOL ON CHRISTIE'S RIGHT HIP IN AN INSIDE THE PANT HOLSTER. CHRISTIE WAS IMMEDIATELY PLACED IN HANDCUFFS AND SAT IN THE FRONT PASSENGER SEAT OF MY PATROL VEHICLE. DUE TO CHRISTIE'S BEHAVIOR, INTOXICATION LEVEL, PREVIOUS HONESTY, DIRECTION OF TRAVEL AND FACT HE WAS CARRYING A CONCEALED FIREARM, I BELIEVED HE WAS TRAVELING TO THE LAKE OZARK STRIP TO COMMIT GUN VIOLENCE TOWARDS THE GENERAL PUBLIC.

WHILE SPEAKING WITH CHRISTIE IN MY PATROL VEHICLE, I SMELLED THE STRONG ODOR OF AN INTOXICATING BEVERAGE COMING FROM HIS BREATH AS HE SPOKE. WHEN ASKED TO RATE HIMSELF FROM 1-10 ON HOW INTOXICATED HE WAS, CHRISTIE RATED HIMSELF A 5.5 AND ADMITTED TO CURRENTLY BEING ABLE TO FEEL THE EFFECTS OF AN ALCOHOLIC BEVERAGE. DUE TO CHRISTIE'S STATEMENTS, I DID NOT ASK HIM TO PERFORM ANY FIELD SOBRIETY TESTS. CHRISTIE ULTIMATELY GAVE A VALID SAMPLE OF HIS BREATH WHICH GAVE A READING OF .115 PERCENT BLOOD ALCOHOL CONCENTRATE.

WHILE TRANSPORTING CHRISTIE TO THE MILLER COUNTY JAIL, HE STATED HE WOULD NEED TO BE IN SEGREGATION BECAUSE HE WOULD KILL HIS CELL MATES WITH HIS HANDS. CHRISTIE FURTHER STATED WHEN HE APPEARS IN COURT, HE WAS GOING TO THROW ITEMS, "A GLASS," AT THE JUDGE.


