Case Notes

I, Deputy David Henderson 2419, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that on 06/02/2019, at 132 Sweet William Rd, Lake Ozark, MO 65049 located within Camden County, Bradley Franklin Sturdivant [REDACTED] 218 lbs DOB [REDACTED] SS# [REDACTED] committed one or more criminal offense(s).

2. The facts supporting this belief are as follows:

On 06/02/2019 at approximately 0138 hours, I responded to Shady Gator's located at 132 Sweet William Rd, Lake Ozark, MO 65049 located within Camden County in reference to an assault that had already occurred. I was further advised that security personnel at the establishment had detained the suspect.

Upon my arrival I observed a white male, who I knew to be Bradley Sturdivant from a previous incident, standing outside of the front entry to the establishment. Bradley was surrounded by security guards and appeared to have a laceration above his left eye. Bradley was placed in handcuffs and sat down beside my patrol vehicle to await EMS.

I spoke with the victim of the assault, identified as JS. JS stated he was called to remove a subject involved in a fight. JS stated Bradley became combative with him. JS stated Bradley called him "n [REDACTED]" and asked him if he "wanted to go back to Africa on the banana boat." JS completed a voluntary written statement.

I next spoke with JS's supervisor, identified as BR. BR stated he and some of his security guards went to deal with a combative customer and remove him from the bar. BR stated Bradley became combative with JS. BR stated Bradley began to make racial comments to JS. BR stated Bradley called JS a "n [REDACTED]" and was making other racial comments. BR stated Bradley continued to be aggressive and began throwing his blood on BR and JS. BR stated he
