Dustin stated to law enforcement he'd consumed alcohol prior to the crash. Dustin radiated a strong odor of intoxicants. Dustin refused medical treatment and refused to provide a blood sample for blood drug and alcohol content identification. A search warrant request was submitted and approved by a Boone County Judge for a sample of Dustin's blood. The warrant was successfully served at a local hospital. Located inside the Chevrolet was prescription medication, an unopened bottle of Fireball Whisky, and a small amount of marijuana.
