## PROBABLE CAUSE STATEMENT

I, Detective Tony Perkins, Boone County Sheriff's Department  
(name and identify law enforcement officer, or person having information as to probable cause),  
UPON MY OATH, AND UNDER PENALTIES OF PERJURY, state as follows:

1. I have probable cause to believe that David Edward Myers

committed the offense(s) of: Murder 2<sup>nd</sup> degree, RSMo 565.021; Armed criminal action, RSMo. 571.015

The facts supporting this belief are as follows:

On 06-13-2020 at about 1857 hours a caller reported a man lying on the road in front of and across the road from 1800 W Sycamore Hills Road. The man, later identified as Anthony Lockwood, was transported by ambulance and pronounced dead at the hospital.

During the course of our investigation a witness was discovered. The witness states sometime around 1815 hours to 1830 hours the witness saw David Myers in an argument with the victim. The witness heard Myers call the victim a vulgar name. Myers then retrieved an elongated pole or stick from his covered porch. Myers then exited his gated property, entering the roadway and chased after the victim, striking the victim with the weapon. The witness could not tell how many times the victim was struck but did see the attack broke off and was then resumed a second time. The witness did not see what became of the victim after the attack.

After the attacks ended, the witness saw Myers swiping his feet and hands in the gravel road, as if trying to wipe away something. Myers then took the weapon used in the attack and took it into his residence.

The witness states Myers was wearing greyish colored shorts and a blueish colored shirt at the time of the attacks. During our investigation detectives spoke with David Myers. Myers was wearing different clothing than he was at the time of the attacks.

When detectives first approached Myers property to speak with him Myers asked for his attorney and walked away from detectives. A short while later, while detectives were speaking with Myers wife, Myers reinitiated contact and began speaking quickly and nervously to detectives. Myers talked about his problems with various neighbors. When Myers heard the victims name, he said "I didn't even know he was back", referring to the victim being incarcerated. Myers told detectives he wouldn't "hunt a man down". Myers told detectives a man has the right to protect himself.
