

# Morgan County R-II School District Re-opening Plan

#### Letter From the Superintendent

#### MCR-II Families.

As you are aware, the past several months have been challenging for our district, our country and the world. We here at Morgan County R-II are beginning a process to open schools and have developed this plan based on our current reality and the needs of our community. First and foremost we believe in the value that our in-person educational program provides. We have taken your advice through our surveys and used that input while developing this plan. We know most of you want to return in person and you want us to make the environment here at school as safe as possible for everyone. This is no easy task and we must all acknowledge that returning comes with a greater risk of exposure despite our best efforts. This document is an outline (not every detail of every day) of our best effort and offers options that we hope will meet everyone's needs.

We ask that you continue to be patient and understanding during this unprecedented time. Our staff and teachers need your grace as we do our best to focus on our number one priority as educators, which is, to provide support to the young people in our community in hopes of improving their quality of life through educational opportunities. I say it specifically that way to emphasize what our focus and purpose truly is. In these trying times it is easy to lose sight of that purpose. If Morgan County R-II is going to be successful we must not lose sight of why we are here and what we do. While we have many distractions during this time our goal remains the same and it is important that we stay focused on improving the life of our young people and continue our educational programs.

One thing I want to mention that is not addressed in this plan is our Open House night. At this time we plan to continue as planned with Open House on August 20th, from 4 - 8 PM. That is something that could change. We do want to encourage the following for Open House:

- Limit family members who attend
- Maintain social distance
- Do not attend if you or anyone in your family may have been exposed or is not feeling well
- We encourage mask wearing

Open house is optional so you should not feel compelled to attend if you are concerned.

Our Re-opening Plan, made public today, July 29th, 2020, is based on what we know at this point. This is subject to change going forward. Please read through this document carefully. Things at school will look different this year. We are all learning about our new normal together and I know we will rise to the challenge as a community and a school district. I look forward to seeing your smiling faces back in our buildings and learning together about how to continue to offer you the best possible educational opportunities here at Morgan County R-II.

# Morgan County R-II School District Re-opening Plan

#### Category 1 - Little to No Community Spread

Regular Classroom environment

Online options are available for families. Contact your school building for more details as plans vary depending on grade level.

#### Category 2 - Significant Community Transmission

School remains open with once a month alternate online learning to prepare for possible shut down.

#### Category 3 - Widespread Community Transmission

Online Learning Only, No face-to-face classes.

Note: These categories will be determined through collaboration with the Morgan County Health Department and are not assigned solely by the school district. Establishing a category is a complicated process that takes into account total cases in our county and surrounding counties as well as the state. It also factors things in like rates of increase and new mutations of the virus that may be more or less contagious. The Morgan County Health Department also keeps up with the latest information from the CDC and factors in that research and information when making the decision to change our category status.

#### Tips to help control the spread of illness

- ★ Wash hands with soap and water for 20 seconds. Use alcohol-based hand sanitizer if soap and water are not available
- ★ Avoid touching your face with unwashed hands.
- ★ Cough or sneeze into your elbow or tissue. Throw tissue in the trash. Wash hands or use hand sanitizer.
- ★ Avoid contact with people who are sick and stay home if you are sick. (see screening checklist for more information on what symptoms to watch for)
- ★ Clean and disinfect frequently-touched objects.

Transportation will still be available for PreK and K students as needed but pick up and drop off times may vary.

The following checklist should be used as a guide: ☐ Fever or chills Cough ☐ Headache ■ Muscle aches ■ Nausea, vomiting or diarrhea ■ New loss of taste or smell ■ New runny or stuffy nose ■ Shortness of breath or difficulty breathing ■ Sore throat Close contact (without face masks for both parties in contact, within six feet, for a duration of 15 minutes or more) with a person who has been diagnosed with COVID-19 in the last 14 days

Students and staff with 2-3 symptoms or exposure should not attend school and consult with their healthcare provider. A doctor's note will be required for return to school.

Note: This list is subject to change and updates will be provided to the school community through multiple sources including website and social media. Perfect attendance incentives will be suspended at this time and learning opportunities will be provided for students that are home ill for longer periods of time.

#### **Confirmed Case in School**

For students diagnosed with COVID-19 by a laboratory test, returning to school is permissible when they have a doctor's note stating they can return.

Returning to school for children with a cluster or 2-3 symptoms but no official COVID-19 diagnosis is at the discretion of their doctor and are allowed to return with a note from the doctor.

Students with only a fever:

- 1. **Without a doctor's note** Must remain fever free for 72 hours without the use or fever reducing medications.
- With a doctor's note that indicates a diagnosis not related to respiratory illness, influenza or COVID-19 - Must be fever free for 24 hours without fever reducing medications.

#### **Contact Tracing Following a Confirmed Case in School**

ш	An initial short-term dismissal may be required to allow the local health officials to gain a
	better understanding of the COVID-19 situation impacting the school. This allows the
	local health officials to help the school determine appropriate next steps, including
	whether an extended dismissal duration is needed to stop or slow further spread of
	COVID-19.
	Local health officials' recommendations for the scope and duration of school dismissals
	will be made on a case-by-case basis.
	During an extended dismissal all activities may also be cancelled.
	During school dismissals, school facilities will be disinfected according to CDC and local
	public health officials guidance.
