

The Prosecuting Attorney of the City of Columbia, State of Missouri, by and through the undersigned Assistant City Counselor, charges that the defendant in violation of Section 11-98 of the Ordinances of the City of Columbia, committed the offense of Powers and duties of director in event of epidemic, and Order 2020-07, Section 106, Restaurants and Bars and incorporated by reference and punishable under Section 1-8 of the Columbia Code of Ordinances, in that on or about July 20, 2020, at or near 3304 West Broadway Business Park Court, within the city limits of Columbia, Missouri, the above named defendant operated a bar and failed to ensure social distancing directives between patrons and also operated a standing bar or counter service as prohibited by Order of the Director of the Columbia/Boone County Department of Public Health and Human Services.
