
COMPLAINT

PROBABLE CAUSE STATEMENT

I, ETHAN DANIEL WILD

knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that on / / , at

SAROEUN MARK SORM A/M committed one or more criminal offense(s): 570.025-001Y202020 ROBBERY - 2ND DEGREE F/M: F COUNTS: 1 CHARGE TYPE: S

2. The facts supporting this belief are as follows:

On 01/11/2021 at approximately 1538 hours, Saroeun Sorm committed the offense of Robbery in the second degree at Missouri. The victim stated Sorm and left and headed Northbound on vehicle. stated was driving and Sorm was in the passenger side of the vehicle. stated Sorm grabbed the wheel, and forced them into the parking lot directly north of as they were traveling Northbound on .

stated Sorm said he was taking the car, and started reaching over and pushed out of the vehicle. stated Sorm said he was taking the car. stated Sorm said, "Fuck you bitch take me to jail" as he was taking the vehicle. stated Sorm said he was going to "beat the breaks off of" I observed a scrape on left arm.

Witness stated fell out of the driver's side of the vehicle, and it looked like Sorm hit or punched. stated it appeared Sorm punched and opened the door all in the same motion. stated then got up and began to fight over the wheel. stated Sorm then climbed over the center console, got into the driver's seat and left the scene with vehicle.

Witness stated witnessed fall out of the driver's side of the vehicle and it appeared Sorm lunged at. stated Sorm then drove off.

On video footage I observed get in the driver's side door and Sorm get into the passenger side.

Post Miranda Sorm stated he does not drive the vehicle and he has no right to it. Sorm stated punched him in the face, and fell out of the vehicle.
