Thank you for your patience. I have investigated your concern and have confirmed the video was made available to students during their junior level AP U.S. Studies class.

The video was part of a larger lesson connected to the following learning standards:

#### English Language Arts Speaking & Listening Priority Standard 11-12.SL.1.C

Viewpoints of Others-Respond thoughtfully to diverse perspectives including those presented in diverse media; synthesize claims made on all sides of

an issue, and, when warranted, qualify or justify their own views and understanding and make new connections in light of the

evidence and reasoning presented

#### Social Studies Priority Standard 9-12.AH.1.PC.B

People, Groups and Cultures- Using a United States' historical lens, describe how peoples' perspectives shaped the sources/artifacts they created.

The lesson asked students to pick from one of four artifacts from history and analyze the author's perspective. One artifact was the Grammy Award winning video directed by Hiro Murai titled "This is America", the others were; "I Hear America Singing" by Walt Whitman, "Let America Be America Again" by Langston Hughes, and "This Land is Your Land" by Woody Guthrie. Students were not forced to watch or read any particular text and were encouraged to think critically of their selected piece. This was not taken for a grade and was used for the purpose of discussion.

The teacher did have a warning by the linked video indicating the video did contain violence. While this is consistent with similar messages we have used for other material containing gun violence (i.e. written text like "The Things They Carried" and "The Crucible"), I did inform the teacher a more descriptive warning is needed. Again, this is consistent with regard to any material we use containing gun violence. In addition, no student is ever forced to watch material they find troubling or disturbing. Again, this procedure was followed by the teacher.

I want to again state I appreciate you bringing this to my attention. Please let me know if you have any additional questions or concerns.
