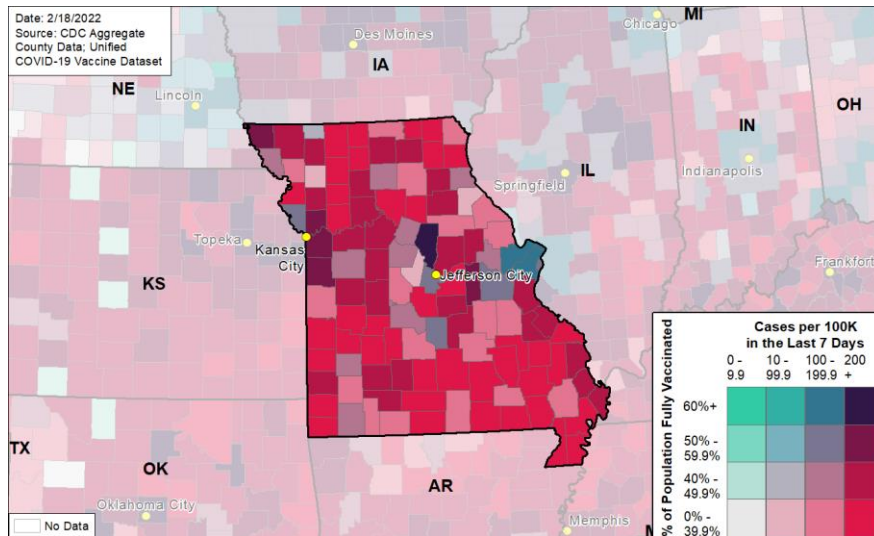

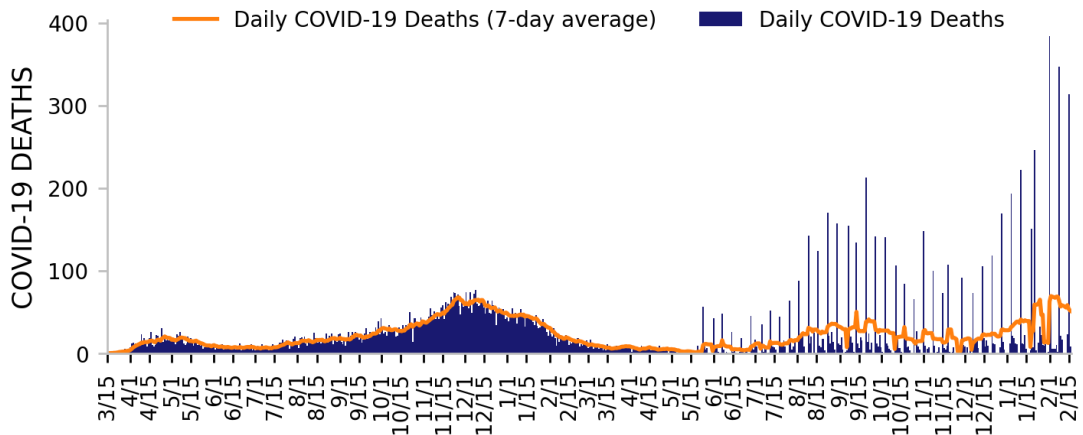

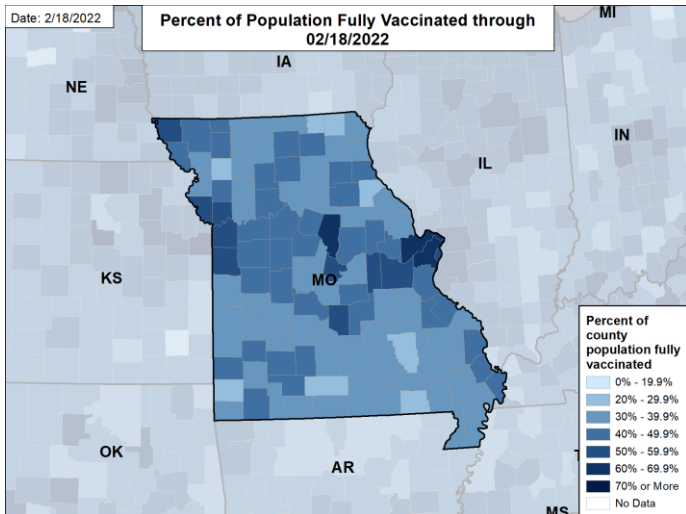

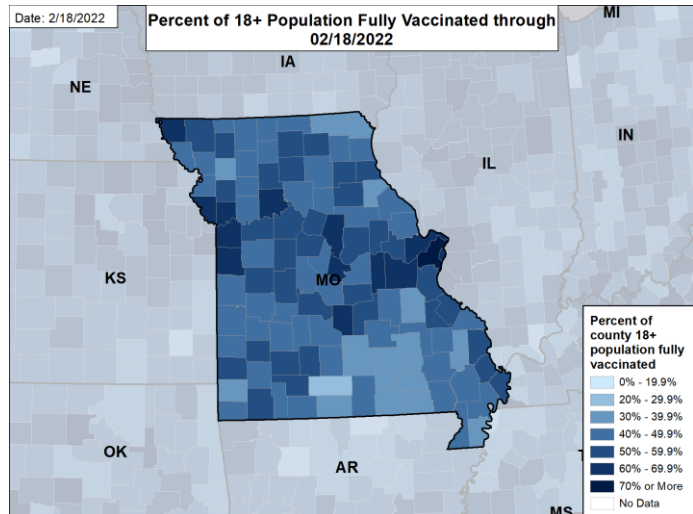

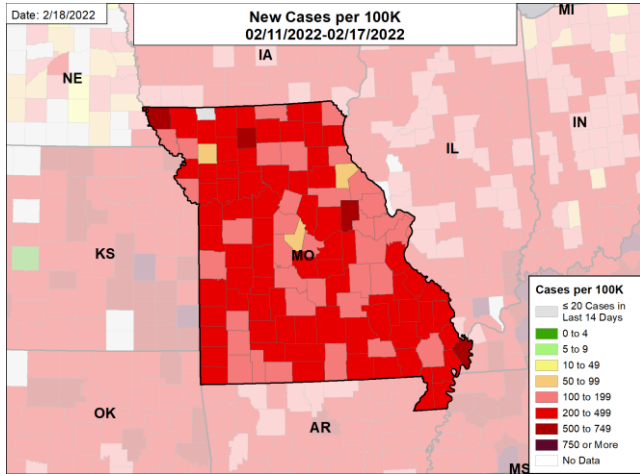

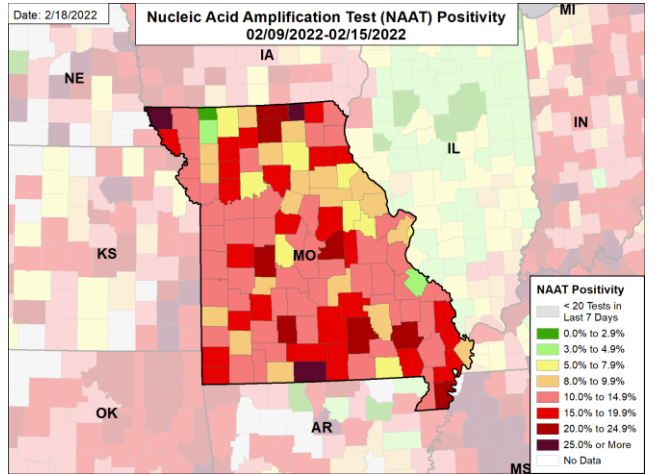

CASE RATES, NAAT POSITIVITY, HOSPITAL ADMISSIONS, AND DEATH RATES

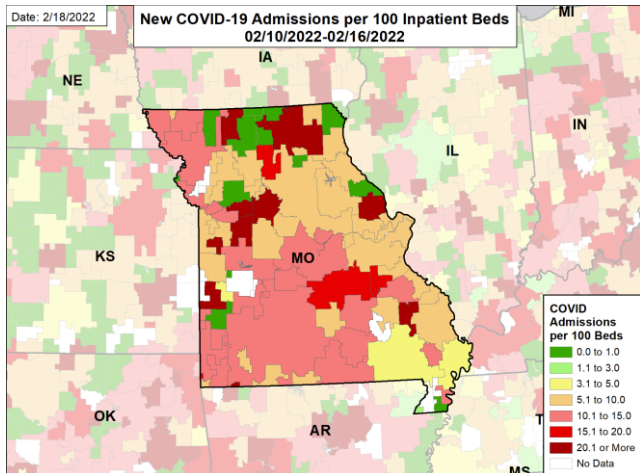

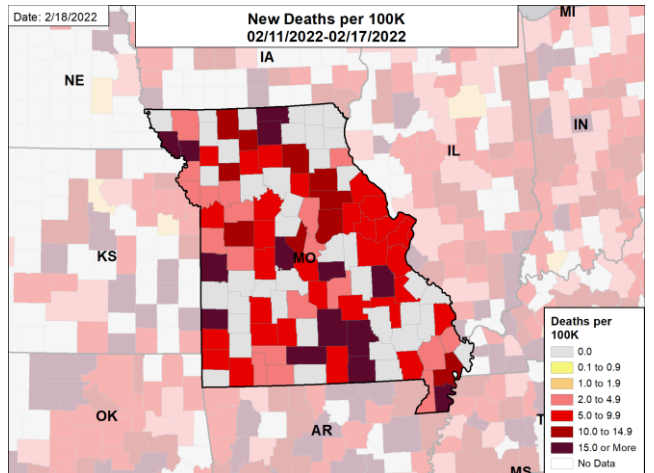

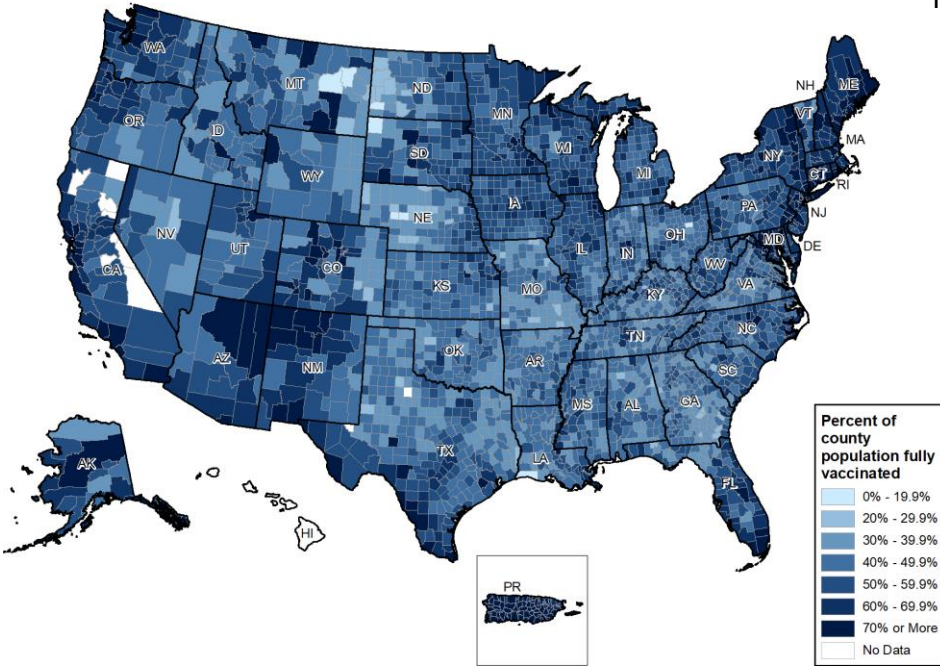

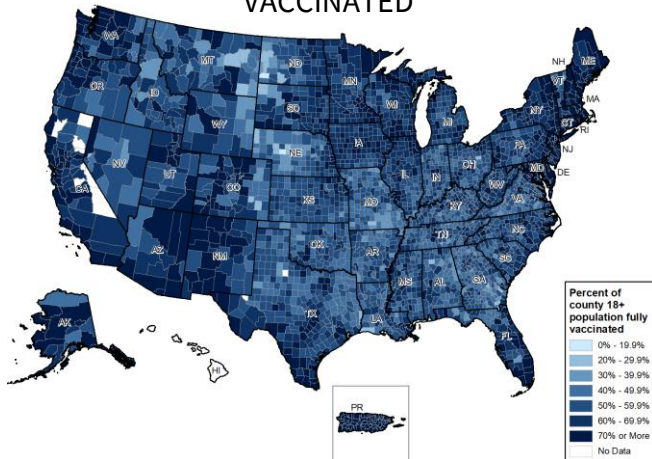
PERCENT OF POPULATION FULLY VACCINATED



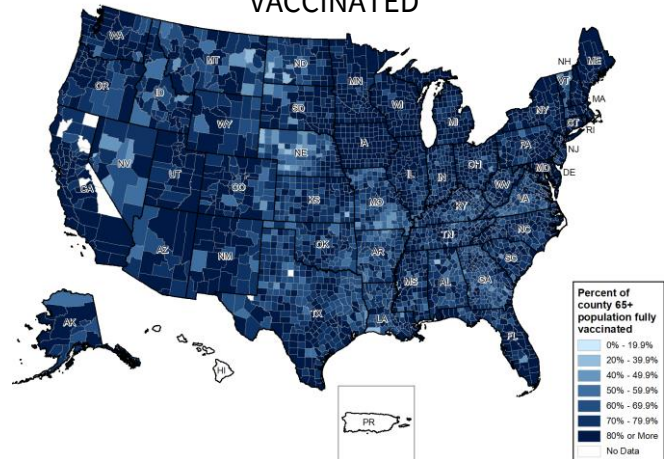

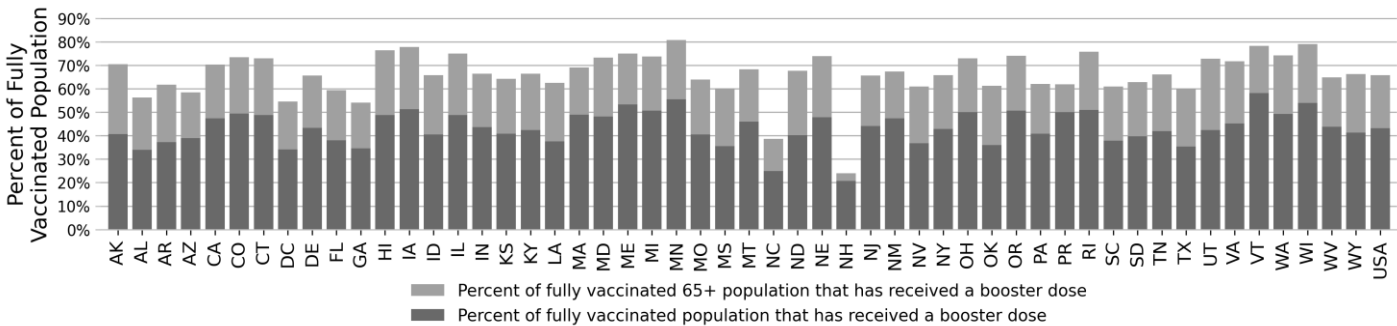

NATIONAL SUMMARY OF VACCINATIONS BY RACE/ETHNICITY

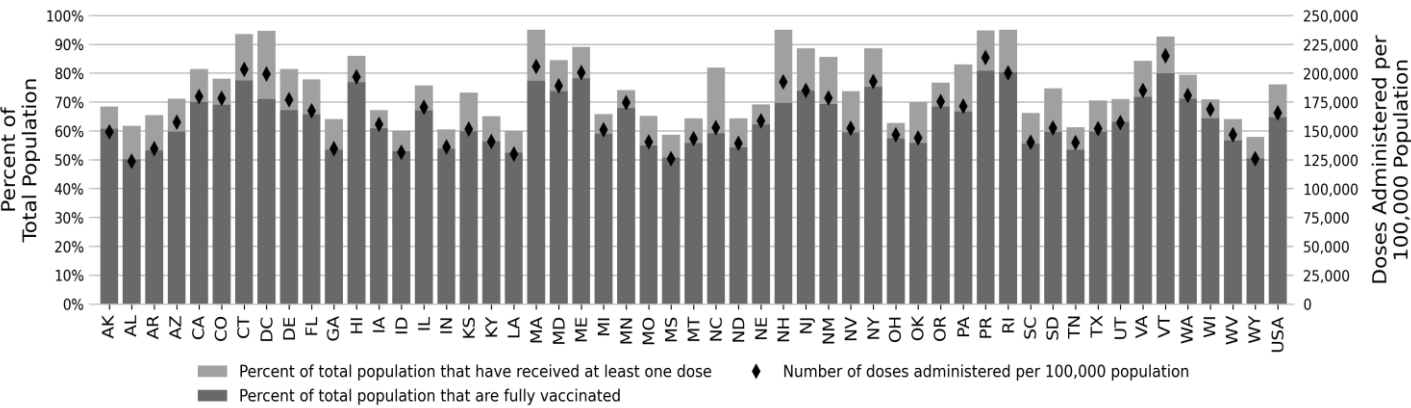

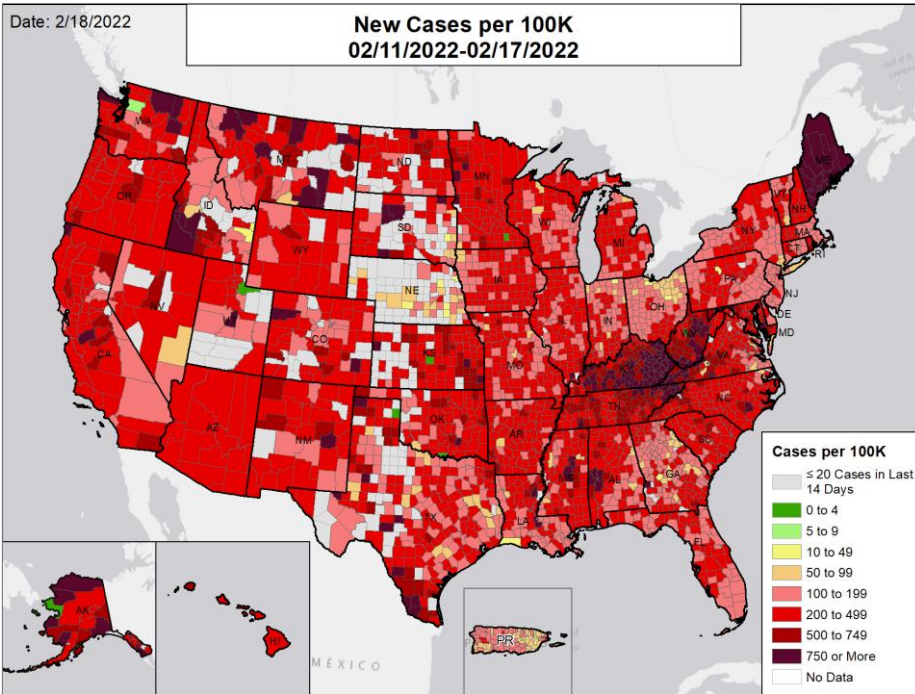

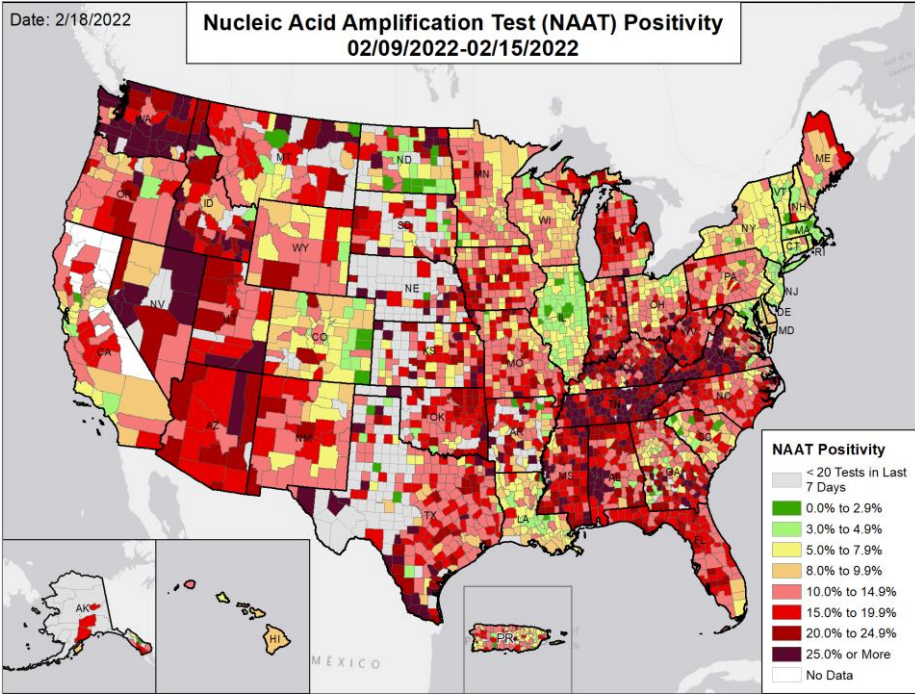

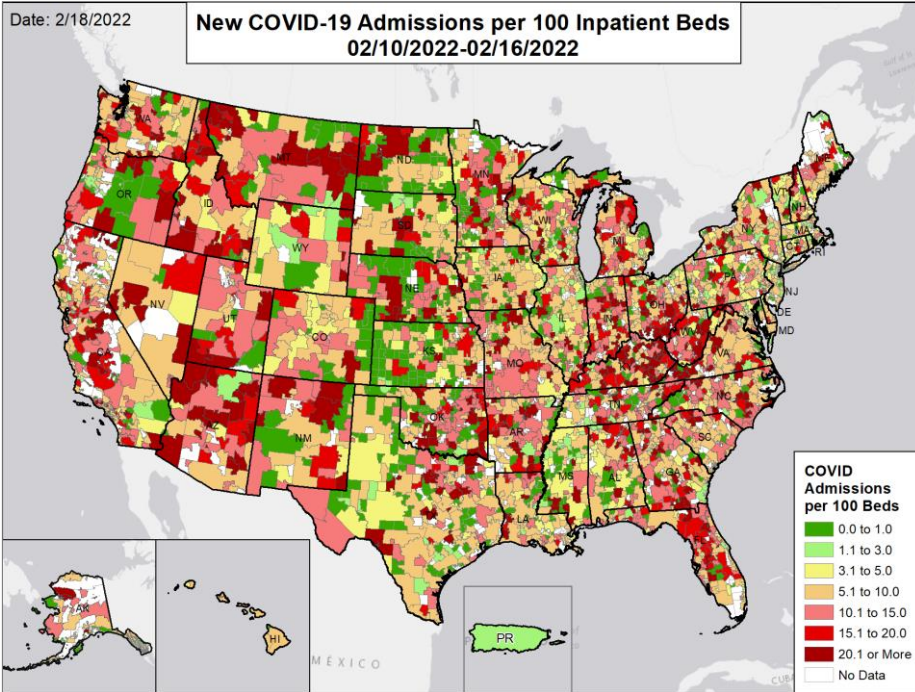

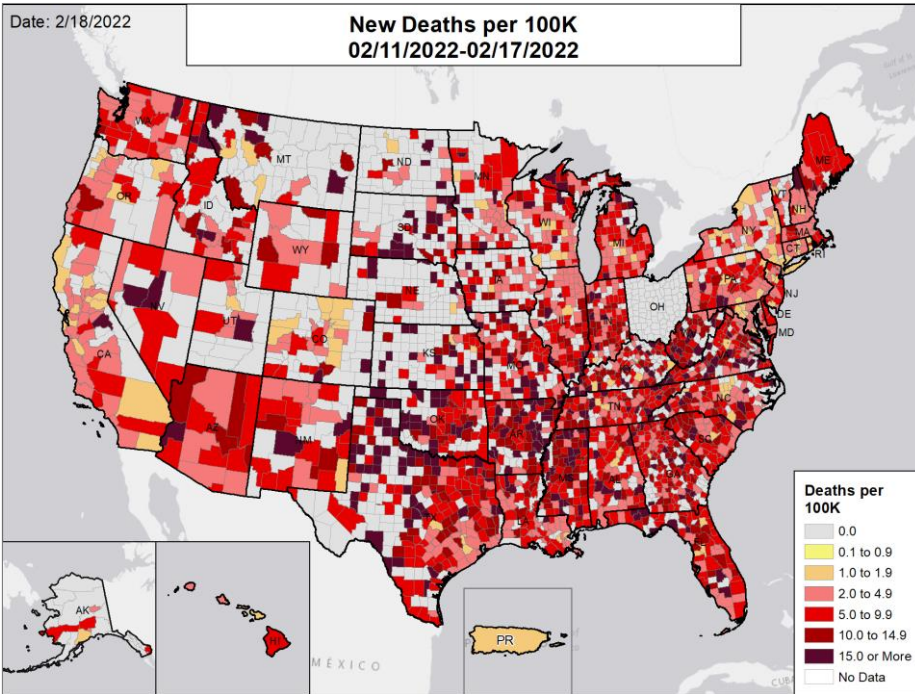

NATIONAL RANKING OF NEW DEATHS PER 100,000



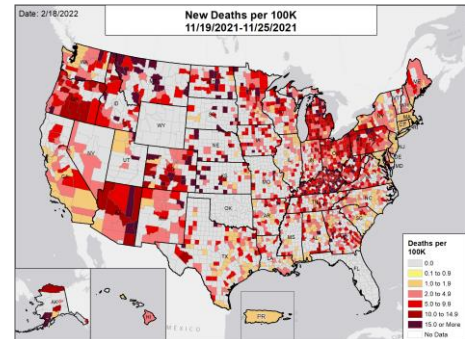
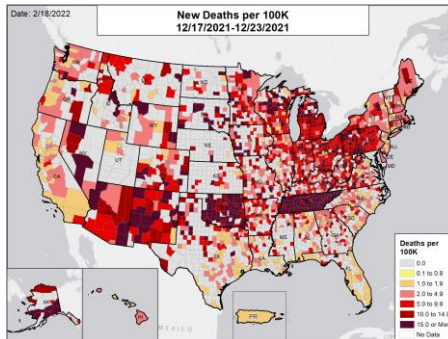
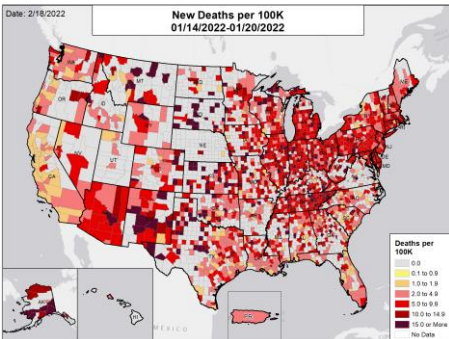

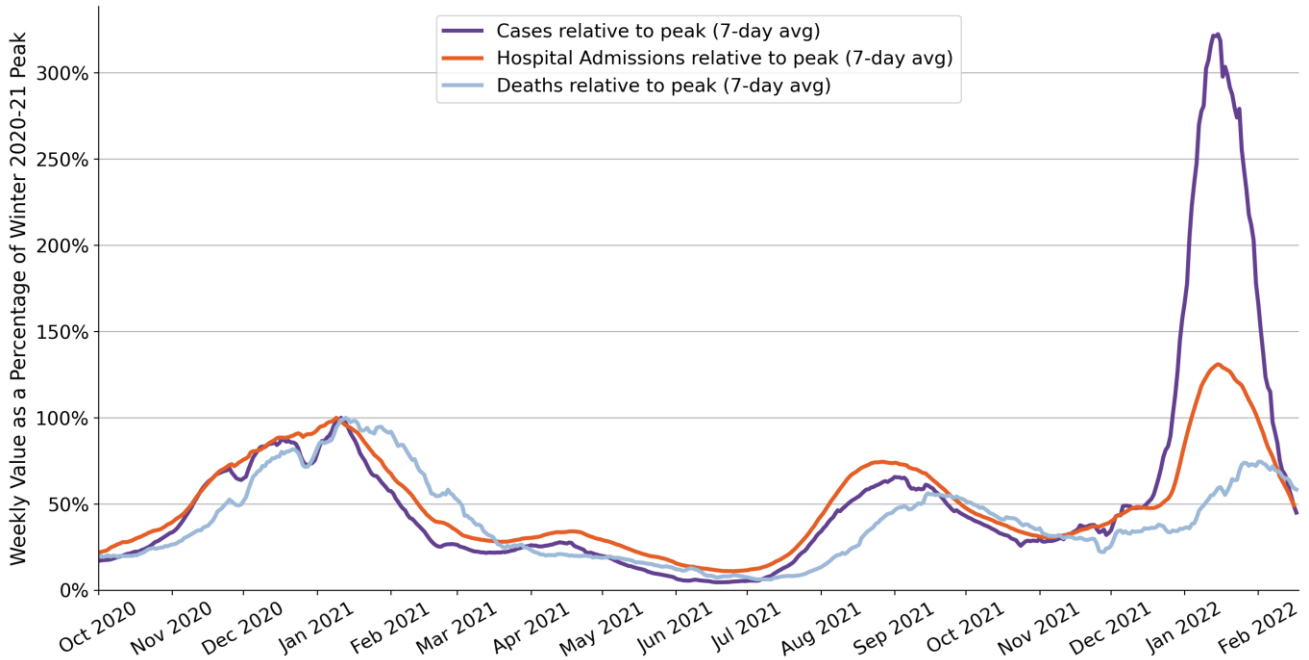

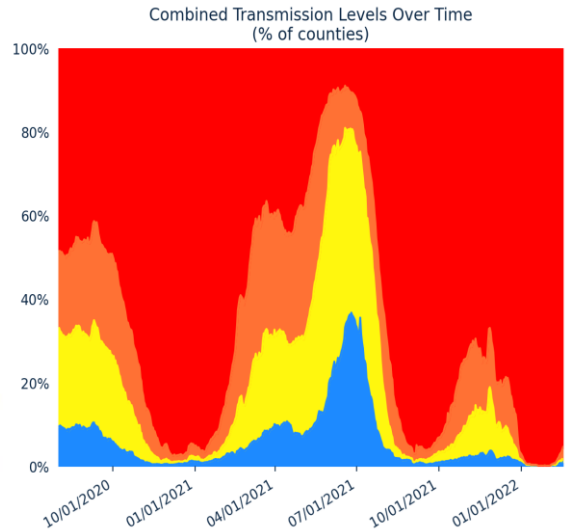

- **Hospitalizations:** Unified Hospitals Dataset in HHS Protect. These data exclude psychiatric, rehabilitation, and religious non-medical hospitals. In addition, hospitals explicitly identified by states/regions as those from which we should not expect reports were excluded from the percent reporting figure. The data presented represents raw data provided; we are working diligently with state liaisons to improve reporting consistency. Data are recent as of 10:33 EST on 02/18/2022.
- **Hospital PPE:** Unified Hospitals Dataset in HHS Protect. This figure may differ from state data due to differences in hospital lists and reporting between federal and state systems. These data exclude psychiatric, rehabilitation, and religious non-medical hospitals. Hospitals explicitly identified by states/regions as those from which we should not expect reports were excluded from the percent reporting figure. Data are recent as of 10:38 EST on 02/18/2022.
- **State, County, and Metro Area Community Transmission Levels**
 - **High Transmission:** Those states, CBSAs, and counties that during the last week reported 100 or more cases per 100,000 population or a lab test positivity at or above 10.0%.

Persons who are fully vaccinated include those who have received both doses of the Moderna or Pfizer-BioNTech vaccine as well as those who have received one dose of the J&J/Janssen vaccine.
