Re: Repealing Ordinance No. 024978; Repealing Sections 22-159(f), 22-159(g), 22-159.1(d) and 22-159.1(e) of the City Code Prohibiting the Use of Residential Roll Carts and Automated Refuse Collection Vehicles for Roll Carts

Executive Summary

The bill would repeal Ordinance No. 024978 calling a special election and would enact the City Code provisions submitted by the initiative measure for removal of the existing language in the City Code which prohibits the use of roll carts for solid waste and/or recycling.

Discussion

At the April 4, 2022 City Council meeting, the Council approved B89-22, enacted as Ordinance No. 024978, to call for a special election for the voters to consider an initiative petition for the repeal of City Code provisions which prohibit the use of residential roll carts and automated refuse collection vehicles for roll carts. At the April 18, 2022 Council meeting, Council Member Pitzer made a motion for leave to reconsider the subject matter of B89-22 along with B88-22 which would have repealed certain sections of the City Code prohibiting the use of residential roll carts and automated refuse collection vehicles for roll carts. There were four (4) affirmative votes for Council to reconsider the subject matter of the two bills.

This bill would repeal Ordinance No. 024978 and would reenact in lieu thereof the provisions of former B88-22. If the new bill is approved by the City Council, an election to submit the initiative to the voters at the August election would no longer be required.

Fiscal Impact

Short-Term Impact: Fiscal impact of the special election is unknown at this time. The cost is based on the various entities who have placed an item on the ballot for any particular election. The prepayment cost for the 2022 municipal and special elections was \$53,822.68 with 18 entities participating. The cost for the August 2022 special election is estimated to be \$140,000.00.

The election costs for the City's participation in the August 2018 special election was \$141,640.74 with three entities participating, and the election costs for the City's participation in the August 2016 special election was \$144,517.62 with five entities participating.

Long-Term Impact: Unknown.
