Stated and Kimo exchanged words and then Kimo shot stated she ran away and then came back to laying on the ground. Pointed at stated it belonged to Almo.

I ran REDACTED in MULES/DOR and it showed the registered owner was Kimo Spivey.

When Officers arrived on scene they responded into Plush Lounge for a male with a gun shot wound, later determined to be Kimo Spivey. Sgt. Brady Wulff was on the phone with Columbia Police Officer Keenen Shouse. Officer Shouse advised that Kimo Spivey was at the University of Missouri Hospital with a gun shot wound.

Kimo Spivey is a convicted felon and was in possession of a firearm during this incident.
