2. The facts supporting this belief are as follows:

On 05/07/2023, at approximately 0215 hours, Columbia Police Department Officers responded to a shots fired call at Plush Lounge, 904 E. Business Loop 70, Columbia, Boone County, Missouri. I was called at 02:28 hours into investigate. Upon arrival Columbia Police Sergeant Brady Wulff stated REDACTED was the victim of a shooting and was pronounced dead. I observed REDACTED body on the ground, under a blanket in the parking lot of Plush Lounge next to REDACTED. I ran the temporary tag on REDACTED through MULES/DOR, and it showed the registered owner was REDACTED.


REDACTED stated she saw "Kimo" shoot and kill REDACTED. REDACTED stated she was in a verbal altercation with REDACTED right in front of REDACTED, which was facing West. REDACTED stated REDACTED was upset with REDACTED, because they let a man with a gun approach him. REDACTED stated REDACTED went to the front passenger door of REDACTED and retrieved his firearm. REDACTED stated Kimo approached her and REDACTED with a gun in his hand. REDACTED stated REDACTED said "fuck y'all and fuck you too Kimo". REDACTED stated REDACTED and Kimo exchanged words and then Kimo shot REDACTED. REDACTED stated she ran away and then came back to REDACTED laying on the ground. REDACTED pointed at REDACTED, in the parking lot and stated it belonged to Kimo.



I asked [REDACTED] how she knew Kimo. [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] also stated she is from Columbia and has seen him around, but didn't know his last name. I provided [REDACTED] a photo of Kimo Spivey. [REDACTED] identified Kimo Spivey as the Kimo she was talking about. [REDACTED] signed and dated the photo.

Kimo Spivey is a convicted felon and was in possession of a firearm during this incident.
