On 03/13/2024, at approximately 1030 hours, TABC, S/A Amorese initiated a investigation into Luke's 32 Bridge, LBDLSR-DAV-1817437 and will confer with the lead detective of missing person case, Riley Strain. On 03/08/2024, at approximately 2200 hours, Mr. Strain was ejected from Luke's 32 Bridge Bar located at 301 Broadway, Nashville and his whereabouts are unknown at this time.

In addition, overserving along with any other possible violations at Luke's 32 Bridge Bar will be investigated during course of this investigation.

On 03/13/2024, SA Amorese emailed Detective Joel Cottrill of the Metro Nashville Police Department, Specialized Investigations Division to ascertain who may be assigned missing person case and to share SA Amorese contact information.

Det. Cottrill sent group email to Det. Chandler, lead on case along with Sgt. Nielsen of the Cold Case Homicide & Missing Persons Squad informing them of TABC, S/A Amorese contact information for any requested assistance and that the TABC has initiated a investigation into Luke's 32 Bridge Bar.

On 03/15/2024, SA Amorese emailed TABC legal team attorney, Samantha Dotson and requested preservation document to hand-liver to Luke's 32 Bridge regarding video, sales receipts, staff members including security personnel for interview and verification purposes.

On 03/15/2024 at approximately 1145 hrs, SA Amorese had a telephone conversation with Riley Strain's, father, Ryan Gilbert via Matter Mr. Gilbert was asked for a list of names and contact information that were with Riley on 03/08/2024 to provide a timeline of events and premises they visited concluding at Luke's 32 Bridge. Mr. Gilbert provided the following list that he was aware of:

Braden Baltz - last seen him and his roommate

Joey Cockell - roommate and helped with police report

AJ Townsend - Delta Chi Mizzou Chapter President - he provided a list of who all was last to see Riley

SA Amorese contacted all persons above and left voicemail and text message requesting call back.

On 03/15/2024 at approximately 1405 hrs, SA Amorese and SA Bakari Phillips visited Luke's 32 Bridge and served a notice of Preservation for Evidence for 03/08/2024 1900 hours to 2400 hours. Manager Rachel Bell signed notice and copy attached in file.

On 03/15/2024. at approximately 1523 hrs, AJ Townsend contacted SA Amorese via telephone# and stated, he is Fraternity President of Delta Chi Mizzou and 4 buses came to Nashville on 03/08/2024. AJ stated, Riley was not on his bus, but he observed him at Hotel at approximately 1630 hours and Riley was in good spirits. AJ was unable to provide any additional information to aid investigation and was not with Riley while he was in the downtown Broadway area.

On 03/15/2024, at approximately 1535 hrs, Braden Baltz contacted SA Amorese via telephone# and stated, he was with Riley at Hotel (Broadway & 8th, Tempo by Hilton) and they as a group at approximately 1630 hrs, on 03/08/2024 walked to Miranda Lamberts bar. Braden stated, Riley ordered a margarita and wasn't sure if he drank anything else at premise. At approximately

1730 hrs., group walked over to Garth Brooks, Friends in Low Places and Riley may had 2-3 rum and cokes and 3 Nutrl (hard seltzer 5% alc.). At approximately 1945 hrs., group walked over to Luke's Bryan and Riley may of had another rum and coke. At approximately 2000 hrs., group walked over to Kid Rock and Braden was unsure of what Riley may of been drinking. At approximately 2030 hrs., group and Riley returned to Luke Bryan's. Braden got him two waters because Riley began slurring his speech. Braden stated, Riley was attempting to close his tab out, but Braden stated, he did not have a tab on this return to Luke Bryans. Braden stated, since bartender heard Riley's slurred speech, she informed bouncer to eject Riley form roof top bar. While Riley was walking downstairs with Bouncer, group may of stated, "meet you at Hotel." Braden stated, I called Riley within 2-3 minutes of ejection of bar and Riley stated, he was a few blocks up on his way to hotel. Braden stated, that was the last time he spoke with Riley.

On 03/18/2024, SA Amorese and SA Phillips awaiting for (3) additional Preservation for Evidence letters drafted by TABC legal team, Samantha Dotson. Notices requested for Miranda Lambert's, Garth Brooks Friends in Low Places and Kid Rock Honky Tonk to serve on premises to secure sales receipts, video, staff personnel that may of served or had contact with Riley Strain for interview purposes.

On 03/18/2024, TABC attorney, Samantha Dotson, email Preservation of Evidence notices to all three (3) additional premises and data will be sent to TABC legal team and shared with SA Amorese and SA Philips for further review and investigation.

On 03/26/2024, the TABC received video summary, alcohol/food purchases and staff personnel roster to include all contact with Riley Strain while he was at Luke 32 Bridge and Miranda Lamberts Casa Rosa from attorneys representing both premises. Report is attached in file.

SA Amorese and TABC Attorney Samantha Dotson discussed further investigative steps and are awaiting reports/video from Garth Brooks Friends in Low Places and Kid Rock's Honky Tonk.

On 04/01/2024 at approx. 1200 hrs., SA Amorese met with Sam Bieber, Director of Security of Garth Brooks FLP at premise and she provided me with a zip drive of complete video from 03/08/2024 displaying all footage of Riley Strain. In addition, zip drive contained all three servers contact information that provided drinks for Riley Strain including credit card transactions which displayed (2) whiskey and coke, (1) rum and coke and (2) Nutrl (hard seltzer 5% alc.) and Friends in Low Places policies. SA Amorese requested snap shot video clips of all sale transactions with Riley Strain and server along with clips of Riley entering and leaving premise. Mrs. Bieber will email snapshots to SA Amorese and TABC attorney Dotson by EOB.

SA Amorese asked if Mrs. Bieber was working the day that Riley was inside premise. Mrs. Bieber stated, she was working and reported no issues with Riley or his group. Mrs. Bieber then spoke with staff members and servers after learning of Riley's missing person case and no issues or unusual activity surfaced during conversations.

On 04/08/2024, Kid Rock's Honky Tonk provided requested documents to TABC legal team, Samantha Dotson. Documents are currently being reviewed by SA Amorese.

On 04/11/2024, SA Amorese contacted Ryan Gilbert, father of Riley Strain and discussed updates. *Mr. Gilbert did not received the medical examiners Toxicology report at this time, however would provide a copy to the TABC for further investigation purposes.*

On 04/16/2024, SA Amorese concluded viewing all video and review of all documents that has been provided up to this date from the (4) premises Mr. Strain had visited on 03/08/2024. After conferral with TABC attorney, Samantha Dotson, it appears overserving to a visibly intoxicated person did not occur to Riley Strain during his visits in all (4) premises. Mr. Strain remained stable on his feet with no visible signs of overserving. In addition, video captured Mr. Strain paying for his beverages and food via his debit card in stable condition along with returning his debit card back into his wallet. At approximately 2140 hours, on 03/08/2024, during ejection from Luke Bryan's Bridge 32, security escorted Mr. Strain from upstairs rooftop bar area to front door exit. During escort, Mr. Strain was with his fraternity brother on stairs, however, after brief conversation among them, fraternity brother returned upstairs while Mr. Strain left Luke Bryan's Bridge 32 premise.

The TABC is awaiting toxicology report to conclude its findings which may lead to further investigation.

On 05/10/2024, SA Amorese contacted Ryan Gilbert, father of Riley Strain and Mr. Gilbert is still

On 05/22/2024, SA Amorese contacted Ryan Gilbert, father of Riley Strain and Mr. Gilbert is still awaiting Toxicology report.

On 06/26/2024, the TABC received the report of investigation by the Davidson County Medical Examiners Office, Autopsy and Toxicology report for Riley Strain under State# 24-19-2053 and Medical Examiner# MEC24-1075. Reports attached in file.

Reports indicated Cause of Death: Drowning and ethanol intoxication

Manner of Death: Accident

Circumstances of Death: Drowned within Cumberland River while intoxicated

This Trace Investigation is requested to be Closed and no clear evidence was established, including eyewitnesses, lengthy video surveillance, sales receipts and numerous interviews to indicate Mr. Riley Strain was visibly intoxicated while he was served.
