The Assistant Prosecuting Attorney, of the County of Warren, State of Missouri, charges that the Defendant,

COUNT I: Assault - 4th Degree - Pursuant To Subdivisions (1), (2), (4), (5)


Charge Code Number: 565.056-001Y20171399.0

In violation of Section 565.056, RSMo, committed the class A misdemeanor of assault in the fourth degree, punishable upon conviction under Sections 558.002 and 560.011, RSMo, in that on or about July 23, 2017, in the County of Warren, State of Missouri, the defendant attempted to cause physical pain to _____ by hitting him.

Defendant is a persistent misdemeanor offender under Section 558.016, RSMo, in that he has pleaded guilty to two or more misdemeanors committed at different times. The misdemeanors are as follows:

On or about November 2, 2004, defendant pleaded guilty to the class B misdemeanor of Property Damage Second Degree in the Circuit Court of Warren County, Missouri, for events occurring on or about March 16, 2004.

On or about March 5, 2013, defendant pleaded guilty to the class A misdemeanor of Possession of Up to 35 Grams of a Synthetic Cannabinoid in the Circuit Court of Warren County, Missouri for events occurring on or about July 7, 2012.

ASSAULT - 4th DEGREE

at or about the date and time of: 7/23/2017 7:13:00 PM to 7/23/2017 7:50:00 PM at the following location in Warren County Missouri: 16349 SHETLAND LN .

The facts supporting this belief are as follows:

On Sunday, July 23rd , 2017 at approximately 1913 hours, I was dispatched to 16349 Shetland Lane for a domestic in progress. Upon arrival I spoke to who advised he was just punched in the face by his son, Kenneth Simpson.

advised he told Kenneth to stop being a little baby and advised he always gets everything he wants from his mother. explained after the statement was made, Kenneth stated he was "Going to kick his ass" and ran down the stairs and punched him once on the left side of his face. advised after he was hit he had fallen to the floor. stated his lip was bleeding due to the strike.

After speaking with he was transported to SSM Lake St. Louis for further care where I was later advised he had several cuts on the inside of his mouth and bruising around his jaw and on his backside.
