Columbia, Missouri, like many communities, faces challenges related to community violence and peer relation problems. In 2022, 16.6% of Columbia Public School Students reported peer relation issues (Boone Indicators Dashboard). To address this, it is crucial to invest in afterschool programming through grant funds. After-school programs provide a structured environment where youth can engage in productive activities, receive academic support, and develop social skills, including conflict resolution. These programs not only keep young people safe during peak hours for juvenile crime but also foster positive relationships with peers and mentors. Research has shown that youth who participate in after-school programs are 68% more likely to graduate from high school compared to their peers who do not participate (Farmers Pal). Current high school graduation rates for Columbia Public Schools are 89.7% (Boone Indicators Dashboard). By securing grant funds for these programs, Columbia can offer more opportunities for youth engagement, thereby reducing the likelihood of violence and contributing to a safer, more vibrant community. Additionally, such investments can alleviate pressures on law enforcement and reduce long-term costs associated with criminal justice and social services, making it a sound economic and social strategy (MU Extension).

#### b. Describe any community-level equity issue(s) that will be addressed by the proposed program and its goal(s). (1000 character limit)

Community violence and the lack of after-school programming are significant equity issues that disproportionately affect marginalized communities. These issues intersect with systemic inequalities, leading to adverse outcomes for vulnerable populations. Communities with fewer resources often lack the funding and infrastructure needed to provide comprehensive after-school programs, leaving children and adolescents without safe, constructive environments during critical hours after school. This absence exacerbates risks of exposure to violence and crime, perpetuating cycles of poverty and disenfranchisement. Graduation rates vary significantly by race and ethnicity. In Columbia, the graduation rate for white students is 93%, for Black students the rate is 83.4% (Boone Indicators Dashboard). Many students, particularly those from marginalized communities, do not have access to the support systems that can help them navigate academic challenges (MU Extension).

To increase access to after-school programming that provides safe, constructive environments for children and adolescents in disproportionately marginalized communities. This will lead to a reduction in exposure to violence and crime through needs-based referrals to resources, positive support systems, and academic enrichment.

This proposal aims to provide comprehensive, no-cost after-school services to students in Columbia, Missouri. This funding will be distributed to local organizations committed to delivering high-quality after-school programs. These services are designed to support academic achievement, foster social-emotional development, and provide safe, structured environments for students during critical after-school hours. Program services offered include academic support, mentorship programs, resource referrals, and youth programming. By keeping students engaged in productive activities during after-school hours, the program reduces the exposure to violence and criminal activities. Safe, structured environments and positive adult relationships are crucial in mitigating the risks associated with unsupervised time. With dedicated academic support, students are more likely to succeed in school and graduate. Additionally, social-emotional learning components, workforce development, job readiness, mentorship and life skills workshops. This helps students achieve upward mobility by developing critical interpersonal skills, emotional regulation, and resilience. These skills are essential for personal success and community well-being. By funding local organizations to provide these services at no cost to students, this program ensures equitable access to essential support and opportunities for all students in Columbia, Missouri. This initiative not only aims to enhance individual student outcomes but also to build a safer, stronger, and more cohesive community.

This initiative is designed to advance equity by providing comprehensive, no-cost services that address the diverse needs of students, particularly those from marginalized and underserved communities. The initiative provides academic support, mentorship, safe environments, positive relationships, and referrals. By offering targeted academic interventions, the program helps to improve academic achievement outcomes. Mentorship provides increased social capital and emotional support needed to navigate challenges. By keeping students engaged in positive activities in safe, structured environments, the program helps reduce their exposure to and involvement in community violence. Needs-based resource referrals ensure that students and their families have access to comprehensive support.
