

Oakview State School is temporarily closed due to Facility Maintenance (HVAC Upgrades).

- Schools identified for closures in 2026 will occur at the end of 2025-26 school year.
- Closure of the six schools scheduled for 2026 involves approximately 60 students (slightly less that 10 percent of the overall current enrollment with MSSD).
- > Student and family transition planning will be school specific and comprehensive.

Building a new Lakeview Woods School first will impact the most students at one time.
The new school would host 109 students.

- The new school allows for the consolidation of five existing schools into one, enriching resources into one location.
- Urban location has resources to design and construct the first school with qualified and experienced vendors.
- Exact location of new school in Kansas City region to be determined through vetting process with OA-FMDC.

- Savings based on 12 schools closing in Phase 1.
- Staffing: Reduction in Force is unlikely most positions will transfer, be re-assigned, or absorbed by current vacancies.
- > Reduction of worker's compensation claims estimated at 25 percent.
- > Deferred maintenance is a one-time cost elimination.
- Savings do not include earnings from real estate transactions via sale of existing schools, buildings, or property.



The term "severely disabled" is no longer used to describe the population of students served by MSSD. A recommendation from the PCG report is to rename MSSD schools so that the new nomenclature is respectful of its students and their potential and describes its reimagined future. The LRPAC agreed with this recommendation.

### Next steps:

- 1. Obtain SBE approval to commence a name changing process
- 2. Develop a Learner Profile that denotes the characteristics of MSSD's students and future programming
- 3. Convene LRPAC Task Force Committee to research names and identify process for legislative changes to the name
- 4. Bring forward a recommended new name to the SBE in August 2026
